This letter provides (1) guidance on Payor Assigned Document (PAD) numbers and (2) payment addresses for certain Indian tribes whose payments go to lockboxes.

Payor Assigned Document Numbers (PAD)

PAD are eight-digit identifiers chosen by the payor. The number must be unique and may be used for only one Form MMS-2014, Report of Sales and Royalty Remittance, and must also be included in the corresponding payment document. Federal and Indian Form MMS-2014s and payments may not be combined. You can find additional information on PAD numbers in the *Minerals Revenue Reporter Handbook*, Release 2.0, dated July 1, 2003. You may access the handbook on our Web site as described at the end of this letter.

The continued failure of some payors to provide this information has caused delays in reconciling accounts and matching payments to Form MMS-2014 documents. To ensure efficient and accurate processing of your Form MMS-2014 and payments, please provide this information at the time of submission. We appreciate your cooperation.


