Abstract</p> <p>Under certain circumstances, lessees are authorized to deduct from royalty payments, the reasonable, actual costs of transporting the royalty portion of produced minerals from the lease to a processing or sales point not in the immediate lease area. When gas is processed for the recovery of gas plant products, lessees may claim a processing allowance. MMS collects information on these transportation and processing allowances on Forms MMS-4295 and MMS-4109 in order to verify the propriety of deductions from royalties paid on Indian leases.</p>
