TO ALL OGOR OPERATORS

Dear Operator:

The Production Accounting Division (PAD) is establishing Facility Measurement Point (FMP) numbers to uniquely identify gas plants that process Federal and/or Indian production. The attached listing identifies the "old" and "new" FMP numbers and is required on the Oil and Gas Operations Report (OGOR) and the Gas Plant Operations Report (GPOR) beginning with the October 1992 production month (due December 15th) in order to facilitate improvements in Production Accounting and Auditing System (PAAS) processing.

The "old" FMP numbers are effective only through the September 1992 production month and will be used when reporting modifications to the OGOR and GPOR for report periods prior to October 1992. No action is required if the number did not change. Some FMP names and operators have been updated to reflect the most current information last provided to PAD.
