

Overview

Released to Industry October 27, 2014

Used for ALL compliance-initiated corrections resulting from compliance activities performed by ONRR/States/Tribes

- Data Mining Reviews (added January 1, 2025)
- Compliance Reviews
- Audits

Accessed in eCommerce like the standard Report for Sales and Royalty Remittance (Form ONRR-2014)

Includes same reporting fields and formats as the standard Form ONRR-2014



CMP-2014 Purpose

Provides ONRR/States/Tribes opportunity to review your royalty lines before you submit them

Streamlines the audit and compliance process

- Ensures use of the correct PAD number and Adjustment Reason Code (ARC) for quicker resolution
- Enhances accuracy of corrections
- Ensures compliance reports are not mixed with monthly reports
- Improves efficiency for ONRR Accounts Receivable and Financial Management when processing adjustments



CMP-2014 Use

Always use the CMP-2014 when making royalty adjustments in response to compliance activities


- Applies to data mining reviews, compliance reviews and audits
- Use the PAD Number stated in the compliance communication or provided by the auditor/analyst
- Use the appropriate Adjustment Reason Codes (ARC)

If unclear, reach out to your ONRR/State/Tribe representative

Failure to report compliance-related adjustments using the CMP-2014, may result in delaying resolution of the issues



CMP-2014 Creation



CMP-2014 Creation

ONRR/STRAC or industry may initiate the CMP-2014 when responding to informal communications (e.g., Data Requests and Preliminary Determinations)

ONRR/STRAC initiates the CMP-2014 for all “formal” communications (Order Letters)

When ONRR creates the CMP-2014, ONRR can pre-load some information for Industry



ONRR Initiated CMP-2014

ONRR initiates the CMP-2014 for ALL formal communications

- Required to use for compliance adjustments in response to an order letter
- ONRR may create a single line or multiple lines
- The Royalty Value after Allowances may show \$1.00
- The company is responsible for ensuring all information is accurate



Form ONRR-2014 Reporting Instructions – CSV Format

Comma Separated Value (CSV) files are first created in an Excel spreadsheet then saved as a CSV file type. All data entry is done in the Excel spreadsheet. Once a CSV file is saved, you will have two files—one with an .xls extension, the other with a .csv extension. NEVER open or double-click the .csv file in Excel! Always make corrections in your original Excel file, then save it to a CSV file. If you need to view the CSV file, view it in a word processor such as WordPad. If you open the .csv file in Excel, you will lose ALL of the formatting from the Excel file. A. Format Requirements

All record fields must comply with the following requirements:

1. The file name must end with a .CSV extension.
2. Commas must separate all fields. Fields that are blank still require a comma to delimit their position. A comma is not required after the last field of a record.
3. Federal and Indian data must be submitted as separate documents.
4. Multiple documents can be present in a single file. Headers and Trailers separate the documents. (See examples below.)
5. Each document must begin with Record Type 1 and end with a Record Type 3 and 4. The number of Record Type 2 lines is listed in line sequential order, the maximum being 50,000 Type 2 lines in a single document.
6. All Record Types are required for each document. Do not use blank lines between multiple documents in a single file. Examples of Record Types used in multiple reports for a single file are shown below.





You may edit an existing CMP-2014 from the Upload File tab


- This option requires you to upload a new file




